The program announced on the day of the Competitions shall prevail.

1. 賽事項目：

男女子五人團體賽

- 參加選手必須年滿十八歲或以上；
 - 參加選手必須五段或以下；無分國籍；
 - 如比賽情況許可的情況下，所有五段的參加選手，都必須協助本會擔任審判；
 - 每隊可以男女子混合自由排位參賽；
 - 每局以 3 分鐘為限，「三本勝負」；決賽每局以 4 分鐘為限，「三本勝負」；
 - 當兩隊未能在法定時間分出勝負，兩隊要各派出一位選手進行「代表戰」，直到一方先取得一分為勝出；
 - 每隊設有一名後備，可以替換該隊任何選手；
 - 分組初賽時，每隊出場次序於報名後不能更改；出線後，每隊可以更改該隊任何選手的排位。
2. 所有比賽將會按照《國際劍道連盟 制定之比賽及審判規則》於 2017 年 9 月 2 日及其後修訂的劍道比賽及審判規則進行。
3. 所有參賽選手所使用的竹劍將會進行竹劍檢定，檢定後會蓋上不同顏色的蓋印，以分辨及確定男女選手所用竹劍合乎賽事規格，詳情如下：

4. 各參加者必須隨報名表格遞交免責聲明，否則不能參加是次比賽及自由練習。
5. 主辦單位將於比賽當日，安排一隊急救隊伍駐守於比賽場地。
6. 獎項：獎盃及獎牌將會頒發給冠軍、亞軍及雙季軍。每一個賽場的審判主任(Shinpan-shunin)會提名該賽場所有項目賽事的敢鬪獎
7. 截止報名日期：**2019 年 6 月 3 日(星期一)**，下午五時正
8. 報名費用：每位港幣 180 元 (已包括比賽費，午餐飯盒及個人意外保險費用)
9. 有關是次比賽安排事宜，主辦單位有權作進一步修訂和最後的決定。

1. Event:

Mixed 5 Members Team

- All participants must be 18 years old or above.
 - All participants must be **5 Dan or below** (regardless of his/her nationality).
 - All 5 Dan players will also need to help out as referee when they are available.
 - There is no regulation for the team formation or positioning. Therefore, even a team with all lady's players is acceptable.
 - The match time will be limited to 3 minutes up to the semi-finals. The final game will be limited to 4 minutes per match. All matches will follow the San-Bon-Shou-Bu (三本勝負) regulations, the player who get two points first will win the match.
 - If both teams ties, each team has to select a representative for Dai-hyo-sen (代表戦). There is no time limit for Dai-hyo-sen and the player who gets one point first will win the game.
 - One spare player is allowed for each team and you may substitute any one player in any match with the spare player.
 - You may not change the order of the players submitted during qualifier game (the league matches); however, the order can be changed after the qualifier game.
2. All matches shall be conducted following "The Regulations of Kendo Shiai & Shinpan of FIK" revised on 2nd September, 2017 and thereafter.
3. Shinai check - to be carried out in the morning. Players must bring the shinais that he/she will be using in the competition for checking. The standards are as follows:

5. First aid team will be stationed at the venue on the tournament day.
6. Prizing: - There will be one winner team, one first winner-up team and two second winner-up

teams; Eight Best Fighting Spirit awards will be given to eight players from each of the top-eight teams.

7. Deadline of Application: On or before 3rd June 2019 (Monday), 5:00pm
8. Entry fee: HK\$180/person (include participation fee, one lunch box and Personal Accident Insurance)
9. The HKKA reserves the right to make final amendments without prior notice.
