When application is received, staff will check the membership of HKKA, if the person belongs to affiliate/dojo, affiliate/dojo master should endorse his/her membership, before staff pass the application to the President of HKKA for approval4. If HKKA does not receive any endorsement from affiliate/dojo master in a month, the application will not be considered.5. Result of application will be given by e-mail within 10 working days after HKKA receives all necessary information.6. Kendo equipments are the property of HKKA. Person who rents the Kendo equipment shall keep the equipment(s) well and return to HKKA after use. HKKA reserves the right to claim for the loss or damage of equipment(s).
