### 全剣連剣道審査会要領 / Details of AJKF Kendo Dan Examination

#### (FIK 加盟国会員用 / Only for FIK Affiliates' Members)

剣道段審査について、以下のとおりご案内します。以下をご参照のうえ、申込み後審査料を事前に支払いのうえ参加されるようお願い致します。

This is to inform you of the details of the AJKF Kendo Dan Examination. Please read the following instructions carefully, pay the application fee in advance after making an application and come to the venue on the designated date.

#### 2. 審査日時 / Date and Time :

上記 2 日の内、希望する日 1 日どちらかを選んで、各連盟からお申込み下さい。申し込み後の日程変更は一切受け付けません。

##### (1) 午前の部:

受付時間: 9:00 – 9:30 am

審査開始: 10:00 am

##### (2) 午後の部:

受付時間: 11:30 – 12:00

審査開始: 午前の部実技 1 が終了後

**※本審査会につきましては、高齢の方より受審していただくことになりましたので、受付時間・年齢を確認のうえ、間違いのないようご参加ください。**

**※受付終了後は、審査の進行上、一切受け付けません。必ず時間を厳守してください。  
また、午前・午後の受審者は入替えて入館しますので、受付時間に合わせて来場してください。**

受付時間、審査開始時間は、2 日間とも同じ。「午前の部」になるか「午後の部」になるかは、年齢毎に分けられ、決定後 4 月上旬には連絡します。★来日が早い場合は、この決定が、行き違いになる恐れがあります。連絡を受ける前に来日した場合は、必ず自分で全剣連国際部門へ問い合わせてください。全剣連雑誌剣窓やホームページにも掲載されます (日本語のみ)。

Exam days: 8 August (SAT) or 9 August (SUN), 2026

You should choose the date of the examination you are willing to take. Please write the examination date (8 or 9, August) in the application form '3. Examination Date'.

**You should apply the application form through the Federation that you belongs to. Please note that you cannot change the date after you submit the application.**

- (1) Morning Group:  
Registration time: 9:00 – 9:30 am  
Examination starts: 10:00 am
- (2) Afternoon Group:  
Registration time: 11:30 – 12:00  
Examination starts: After the Morning group's Jitsugi I

**※ In the Dan examination, elder applicants will be examined first, so please check the reception times and ages to ensure that you are attending the right examinations.**

**\* After reception has finished and the examination has commenced, no more registrations will be accepted so please be punctual. Furthermore, candidates for the morning and afternoon examinations please come to the venue at your allotted reception time to avoid congestion.**

The registration time and the exam starting time are the same for either day. Whether you are placed in the 'Morning group' or in the 'Afternoon Group' will be determined according to the ages of the applicants and it will be informed you in mid-April. ★If you come to Japan quite early and stay until the exam, there is a fear that you might not receive that notice. So please contact AJKF International Office when you have already arrived in Japan before you get this information. The information shall also be carried in the AJKF magazine Kenso and the web site (Japanese page only).

**4. 審査科目/Subjects to be examined :**

- (1) 第一次実技  
(2) 第二次実技 (第一次実技審査合格者のみ)  
**※実技審査においては面マスクまたはシールドを着用してください。**  
(3) 日本剣道形 (第二次実技審査合格者のみ)
- (1) Jitsugi I  
(2) Jitsugi II (Only for those who passed Jitsugi I successfully.)  
**\* Please wear a Men-mask or a face shield in the practical examination.**  
(3) Nippon Kendo Kata (Only for those who pass the Jitsugi II successfully.)

**5. 受審資格・年齢/Qualifications and Age :**

- 1) 受審資格 : ①平成 28 年 8 月 31 日以前に 7 段を取得し、年齢満 46 歳以上で修行年限 10 年以上の者。  
②令和 3 年 8 月 31 日以前に 7 段を取得し、年齢満 65 歳以上で修業年限 5 年以上経過し、加盟団体会長が許可した者。
- 2) 年齢基準 : 本要領および審査における年齢基準はそれぞれの審査日当日とする。  
(8 月 8 日受審者は 8 月 9 日現在の年齢、  
8 月 9 日受審者は 8 月 9 日現在の年齢)

- 1) Qualifications: ①Those who got 7-Dan before 31 August 2016, 46 years old or older, have practiced more than 10 years.  
②Those who got 7-Dan before 31 August 2021, and 65 years or older. These applicants must receive the recommendation letters from the Presidents of the Federations they belong with.
- 2) Age Standard: The age mentioned in this Details and at the examination shall be as of the day of each examination.  
(Age standard will be as follows; 8 August for the applicants for the 8 August exam, and as of 9 August for the applicants for 9 August exam.)

6. 審査料の支払い／Application fee payment :

審査料 (8,800 円、円以外の通貨支払い不可) を下記支払い締切日までに必ず全剣連へお支払いください。支払い締切日までに入金を確認できない場合は、申込みは取消されます。支払いは、以下の方法のいずれかです。(いずれの方法でも、送金は受審申込者の個人名がわかるようにお願いします。) また一旦入金された審査料は、理由の如何にかかわらず返金されません。

\*海外の銀行から上記口座へ銀行送金の場合は、必ず手数料全額支払人払い (Pay-in-full、日本の銀行手数料を含む全ての手数料送金人払い) の手続きで送金すること。(全剣連では、Pay-in-full の手配がされていない送金は受け取りませんので、ご注意ください。外国から日本の銀行への海外送金の手数料体系は複雑で高額なため下記 (3) の方法の検討をお勧めします。

\*万一、地元銀行で Pay-in-full での送金ができない場合、三菱 UFJ 銀行の手数料は次の通りです。到着金額が 8,000 円以上であれば、手数料は 4,000 円、また、それが 8,000 円未満の場合は、到着金額の半分が手数料となります。

The application fee (¥8,800, Only Japanese Yen is accepted) must be paid to AJKF by the following payment deadline. If the AJKF accounting department cannot confirm the payment by the deadline date, your application is cancelled. You should use either of the following ways. (In either way, please make sure that the personal name of the applicant should be identified.) Once the application fee is received by AJKF, it would not be returned in any case.

**\*In case a remittance to the above bank account is made from overseas banks, please make Pay-in-full arrangement (i.e., the remitter pays all fees, including Japanese bank charges) at your local bank. (The AJKF will not accept a remittance without the Pay-in-full arrangement. The bank commission system for overseas remittance from a foreign country to a Japanese bank is complicated and expensive, so we recommend the method 3) below.**

**\*If you are unable to send money via Pay-in-full at your local bank, the commissions of the MUFG Bank, Ltd are as follows;**

**If the arrival amount is over 8,000 yen or more, the commission will be 4,000 JPY, and if it is less than 8,000 JPY, half of the arrival amount will be the commission.**

**\*We also accept bank transfers from within Japan.**

- 3) PayPal Settlement

PayPal payment has been added to this issue. Payments can be made using the form at the following URL. Please note that **PayPal will include a handling fee, which will be borne by AJKF** (so that it can be used for future judging sessions, etc.).

**\*Please note that from now on we will not be accepting registered cash or payments made in person at our office.**

#### **7. 合格後の登録料支払い／Registration fee payment by the successful applicant :**

合格者氏名は、審査終了後に京都市立体育館正面玄関に掲示されます。

合格者は、登録料（72,000 円、円以外の通貨支払い不可）を全剣連にお支払いいただきます。審査後に、合格者が確定しましたら、必ず自分が合格かどうかを確認してください。支払方法は、前述の審査料支払い方法と同様にいずれかの方法で下記期日までにお支払いください。前述の送金先や送金時の注意、添付別紙を必ずご参照ください。なお PayPal による決済については、合格案内のメールで支払いページの URL を記載します。

**(会場での現金による登録料支払いは受け付けませんので、ご注意ください。)**

The names of the successful applicants are posted at the front entrance of the Gym.

The successful applicants are requested to pay the registration fee (¥72,000. Only Japanese Yen is accepted) to AJKF. When the successful applicants are fixed after the examination, you confirm that you passed the examination successfully without fail. You should use either of the payment methods described in the above-mentioned 'Application Fee Payment' and pay the registration fee by the deadline below. Please refer to the aforementioned account, the notes and the attachment for sure. For PayPal payments, the URL of the payment page will be included in the acceptance announcement e-mail to Federations.

**(You cannot pay the registration fee at the venue. Please note that the payment at the venue in cash is NOT accepted.)**

#### 8. 証書の発行／Certificate Issue :

証書は、登録料入金を確認後に全日本剣道連盟から発行され、各国剣道連盟会長あてに郵送される予定です。各合格者宛の送付はいたしませんのでご注意ください。

The Dan certificate will be issued by AJKF after the registration fee receipt is confirmed. The certificate will be sent to the President of each country federation by post mail. **Please note that the certificate will not be sent to each successful applicant.**

#### 9. 個人情報保護法への対応／Compliance with the Personal Information Protection Law

申込書に記載される個人情報（登録国名、氏名、生年月日、年齢、称号、段位、職業等）は全日本剣道連盟が実施する本審査会運営のために利用する。なお、登録国名、氏名、年齢等の最小限の個人情報は必要の都度、目的に合わせた公表媒体（掲示用紙、ホームページ、剣窓等）に公表することがある。更に、剣道の普及発展のためマスコミ関係者に必要な個人情報を提供することがある。

In the application form, personal information such as registered country, name, D.O.B., age, Shogo, Dan grade, occupation, etc.) will be used by the All Japan Kendo Federation for the purpose of holding this examination. Basic information such as registered country, name, age, etc., might be announced in public in AJKF related bulletins, webpage, and *Kenso* (the monthly AJKF publication), etc. Furthermore, we may provide personal information to the media to promote kendo.

#### 10. その他／Others :

- 1) 日本剣道形は打ち太刀・仕太刀どちらか一方を行ないます。どちらになるかは会場で指示されます。使用する用具は全剣連で用意します。
- 2) 会場での口頭・文書での指示や掲示は全て日本語でのみ行われます。実技 1、2、剣道形審査によって審査場が変わる場合もあります。審査の順番や方法等は、全て会場での指示や掲示に従って行動してください。  
実技に合格しても剣道形審査を欠席すると、審査不合格となり、また後述の剣道形再受審の資格もなくなりますのでご注意ください。
- 3) 各自安全面に注意して審査を受けること。貴重品の管理は各自行うこと。審査中の事故に対しては、主催者では応急処置を講じ、病院等で治療を受けられるよう手配する。また、主催者は、審査中の受審者の事故に対して傷害保険に加入していますが、受審者各自が旅行期間中の疾病傷害保険等に必ず加入してくるようしてください。（主催者の傷害保険は審査中の傷害の治療費が対象で、それ以外は対象とはならず、審査中以外の事故等に対して、主催者は一切責任を持ちません。）
- 4) 合格した場合は、必ず所属剣道連盟へ（およびヨーロッパの場合はヨーロッパ剣道連盟も）合格を報告すること。
- 5) 実技審査に合格後、日本剣道形のみ不合格だった場合は、その後 1 年に限り形のみ再受審が認められます。（実技合格後に形審査を受けなかった場合は、再受審の対象になれま

せんのでご注意ください。)

- 6) 審査会場には駐車場がありませんので、車での来場はご遠慮ください。
- 7) 全剣連で以前に段受審や段取得をしている方は「全剣連番号」が登録されています。今後同じ種目(剣道)で受審を申込み場合は、申込書の所定欄にその番号をご記入ください。  
(全剣連番号をお持ちの方は、今後の受審申込提出時に、免状のコピーを添付いただく必要はありません。ただし申込書の所定欄に必ずこの番号をご記入ください。わからない方はお問い合わせください。)

※本審査会の入場は、受審者を優先とし、見学者(付添・家族含む)につきましては、会場の収容人数により入場者数を制限した事前登録制といたします。ただし、申込多数の場合は先着順といたしますので、ご了承願います。

※見学者の事前登録については、後日、各都道府県剣道連盟へ案内通知を送りますので、そちらよりご登録ください

- 1) You will take either Uchidachi or Shidachi part at the Nippon Kendo Kata examination. The position for the Kata examination will be announced at the venue after the Jitsugi examination is finished. Be aware that the instructions at the venue, will be only given in Japanese. The equipment that will be used at the Nippon Kendo Kata examination will be prepared by AJKF in advance.
- 2) Please note that all the instructions and notices (oral or written) at the venue are given only in Japanese. The examination venues of Jitsugi 1, Jitsugi 2 and Kendo Kata could be different. All applicants are requested to follow the instructions and notices at the venue.  
Even if you pass the Jitsugi exam successfully, if you do not attend the Kata exam, you shall not pass the exam. And you also lose the eligibility for the 're-taking for Kata exam' if you do not attend the Kata exam.
- 3) Each of the participants should pay careful attention to safety for his/her own and others. They should also have to care for their own valuables and belongings. In case of an accident (injury of an applicant) during the examination, the hosting organization shall give first-aid treatment and make arrangements for medical treatment at a hospital on the day of the event. However, it is strongly recommended that each applicant take out insurance that covers the expenses for diseases/accidents during the whole travel period without fail. (The accident insurance by the hosting organization shall cover the expense of the doctor's bill for the injury during the examination only. Other expenses shall not be covered, and the hosting organization shall not be responsible for any of those other incidents.)
- 4) When you pass the examination successfully, you are strongly recommended to report it to your country federation (\*If your Federation belongs to EKF, you should report the result to both the Federation you belong with, and the EKF).
- 5) If you unfortunately fail the Nippon Kendo Kata after you successfully pass the Jitsugi I and II, you are allowed to have the right to take the Nippon Kendo Kata examination only at the examinations in future. This right shall be valid only one year after the examination in question. (As we've mentioned in the above, if you skip the Kata exam even if you passed the final Jitsugi examination, you are not qualified for this 're-application for Kata exam only' treatment.)
- 6) As there is very limited parking space at the venue, please use public transportation or come to the venue on foot.

If you have applied for a Dan/Shogo examination or received a Dan/Shogo certificate issued by AJKF, you will have the AJKF Registration Number. Therefore, if you apply for an AJKF Dan examination, please write the AJKF number of your own in the application form. (\*If you have the AJKF registered Number, you don't have to submit the copy of your current Dan certificate when you apply for a Dan exam in future.

Please write your AJKF number on the application form. If you lost or forgot the number and want to confirm the AJKF number, please contact the AJKF International Office.)

- \* **Priority for admission will be given to examinees, while the number of visitors (including chaperones and family members) will be limited by the capacity of the venue. However, if there are too many applications, the admission will be on a first-come, first-served basis.**
- \* **For pre-registration of visitors, an information notice will be sent to each prefectural kendo federation at a later date, so please register there.**

外国剣連所属者のお問い合わせや依頼等については、審査当日に会場係員は対応できませんので、ご質問等ありましたら、必ず全剣連国際部門へ事前または事後に各剣道連盟を通じてお問い合わせください。ご協力をお願い申し上げます。

Please note that the staff at the exam venue cannot deal with the questions or requests concerning the applicants from the foreign federations because they do not speak English or they are not familiar with the procedure for the foreign Kendo federations' members which is completely different from the domestic one. So, if you have any questions or requests, please be sure to contact the International Office of AJKF in advance or after the examination **through each federation.**
