全剣連剣道審査会要領／Details of AJKF Kendo Dan Examination (FIK 加盟国会員用／Only for FIK Affiliates' Members)

剣道段審査について、以下のとおりご案内します。以下を参照し、申込み後、審査料を事前に支払いのうえ参加されるようお願い致します。

This is to inform you of the details of the AJKF Kendo Dan Examination. Please read the following instructions carefully, make an application, pay the application fee in advance and come to the venue on the designated date and time.

※ It has been decided that older applicants will be examined first, so please check the reception times and ages to ensure that you are attending the right examinations.

* After reception has finished and the examination has commenced, no more registrations will be accepted so please be punctual. Furthermore, candidates for the morning and

afternoon examinations please come to the venue at your allotted reception time to avoid congestion.

4. 審査科目/Examination Subjects :

1) 実技

※実技審査においては面マスクまたはシールドを着用してください。

2) 日本剣道形 (実技審査合格者のみ、打太刀・仕太刀は開始前に係員より連絡。形審査で使用する木刀は、全剣連で準備する。)

1) Jitsugi

* Please wear a Men-mask or a face shield in the practical examination.

2) Nippon Kendo Kata (only for those who passed Jitsugi successfully, AJKF staff inform which role, Uchidachi or Shidachi, you should play before starting. AJKF will prepare the Bokuto used for the Kata examination.)

5. 受審資格・年齢/Qualifications & Age :

1) 受審資格 : ①令和 2 年 4 月 30 日以前に 6 段を取得した者

* なお、令和 2 年 5 月愛知県での剣道六段審査会合格者も含みます。

②令和 5 年 4 月 30 日以前に六段を取得し、年齢満 65 歳以上で修業年限 3 年以上経過し、加盟団体会長が許可した者。

* 令和 5 年 5 月愛知県での剣道六段審査会合格者も含みます。

2) 年齢基準 : 本要領および審査における年齢基準は審査日当日 (4 月 30 日) とする。

1) Qualifications : ①Those who received 6-Dan before 30 April 2020.

②Those who received 6-Dan before 30 April 2023, and are over 65 years old. In this case, the applicant should have practiced for more than 3 years after he/she has 6-Dan and must receive the recommendation letter from the president of the Federation he/she belongs to.

2) Age standard: The age mentioned in this Details and at the examination shall be as of the day of the examination.(30 April)

* If you are applying for Dan examination in Aichi on May, you cannot apply for this Dan examination in Kyoto. Likewise, if you are applying for this examination in Kyoto, you cannot apply for the examination in Aichi.

6. 審査料の支払い/Application fee payment :

審査料 (7,700 円、円以外の通貨支払い不可) を下記支払い締切日までに必ず全剣連へお支払いください。支払い締切日までに入金を確認できない場合は、申込みは取消されます。支払いは、以下の方法のいずれかです。(いずれの方法でも、送金は受審申込者の個人名がわかるようにお願いします。) また一旦入金された審査料は、理由の如何にかかわらず返金されません。

***海外の銀行から上記口座へ銀行送金の場合は、必ず手数料全額支払人払い (Pay-in-full、日本の銀行手数料を含む全ての手数料送金人払い) の手続きで送金すること。(全剣連では、Pay-in-full の手配がされていない送金は受け取りませんので、ご注意ください。外国から日本の銀行への海外送金の手数料体系は複雑で高額なため下記 (3) の方法の検討をお勧めします。**

***万一、地元銀行で Pay-in-full での送金ができない場合、三菱 UFJ 銀行の手数料は次の通りです。到着金額が 8,000 円以上であれば、手数料は 4,000 円、また、それが 8,000 円未満の場合は、到着金額の半分が手数料となります。**

The application fee (¥7,700, Only Japanese Yen is accepted) must be paid to AJKF by the following payment deadline. If the AJKF accounting department cannot confirm the payment by the deadline date, your application is cancelled. You should use either of the following ways. (In either way, please make sure that the personal name of the applicant should be identified.) Once the application fee is received by AJKF, it would not be returned in any case.

***In case a remittance to the above bank account is made from overseas banks, please make Pay-in-full arrangement (i.e., the remitter pays all fees, including Japanese bank charges) at your local bank. (The AJKF will not accept a remittance without the Pay-in-full arrangement. The bank commission system for overseas remittance from a foreign country to a Japanese bank is complicated and expensive, so we recommend the method 3) below.**

***If you are unable to send money via Pay-in-full at your local bank, the commissions of the MUFG Bank, Ltd are as follows;**

If the arrival amount is over 8,000 yen or more, the commission will be 4,000 JPY, and if it is less than 8,000 JPY, half of the arrival amount will be the commission.

*We also accept bank transfers from within Japan.

3) PayPal Settlement

PayPal payment has been added to this issue. Payments can be made using the form at the following URL. Please note that **PayPal will include a handling fee, which will be borne by AJKF** (so that it can be used for future judging sessions, etc.).

*Please note that from now on we will not be accepting registered cash or payments made in person at our office.

7. 合格後の登録料支払い／Registration fee payment by the successful applicant :

合格者は、登録料（41,250 円、円以外の通貨支払い不可）を全剣連にお支払いいただきます。日本剣道形審査後に、合格者が確定しましたら、必ず自分が合格かどうかを確認してください。

登録料の支払いは、前述審査料支払い方法と同様の方法で、後日下記指定日までにお支払いください。前述の送金先や送金時の注意、添付別紙を必ずご参照ください。なお PayPal による決済については、合格案内のメールで支払いページの URL を記載します。

（会場で現金での登録料支払いは、一切受け付けませんのでご注意ください。）

The successful applicants are requested to pay the registration fee (¥41,250, Only Japanese Yen is accepted) to AJKF. When the successful applicants are fixed after the Nippon Kendo Kata examination, you confirm that you passed the examination successfully without fail.

You should pay the registration fee by either of the payment methods described in the above-mentioned 'Application Fee Payment' later by the following deadline. Please refer to the aforementioned account, the notes and the attachment for sure. For PayPal payments, the URL of the payment page will be included in the acceptance announcement e-mail to Federations.

(You cannot pay the registration fee at the venue. Please note that the payment in cash at the venue is not accepted at all.)

Payment deadline : 31 May 2026

8. 証書の発行／Certificate Issue :

証書は、登録料入金を確認後に全日本剣道連盟から発行され、各国剣道連盟会長あてに郵送される予定です。各合格者宛の送付はいたしませんのでご注意ください。

The Dan certificate will be issued by AJKF after the registration fee payment is confirmed. The certificate will be sent to the President of each country federation by post. **Please note that the certificate will not be sent to each successful applicant.**

9. 個人情報保護法への対応／Compliance with the Personal Information Protection Law

申込書に記載される個人情報（登録国名、氏名、生年月日、年齢、称号、段位、職業等）は全日本剣道連盟が実施する本審査会運営のために利用する。なお、登録国名、氏名、年齢等の最小限の個人情報は必要の都度、目的に合わせた公表媒体（掲示用紙、ホームページ、剣窓等）に公表することがある。更に、剣道の普及発展のためマスコミ関係者に必要な個人情報を提供することがある。

In the application form, personal information such as registered country, name, D.O.B., age, Shogo, Dan grade, occupation, etc.) will be used by the All Japan Kendo Federation for the purpose of holding this examination. Basic information such as registered country, name, age, etc., might be announced in public in AJKF related bulletins, webpage, and *Kenso* (the monthly AJKF publication), etc. Furthermore, we may provide personal information to the media to promote kendo.

10. その他/Others :

- 1) 会場での口頭・文書での指示や掲示は全て日本語でのみ行われます。通訳・翻訳等外国語使用者への特別な配慮はありません。会場での係員指示や掲示に従って行動してください。
- 2) 実技と剣道形の審査場所は、違う会場の場合があります。実技審査合格の発表は、受審した試合場で行われ、合格者へは剣道形会場の指示がありますので、実技合格発表までは受審場の受付デスク近くにいるようにしてください。(実技の発表は数組終了ごとに行われます。) 日本剣道形審査の会場へ移動する場合は、係員の案内に従って速やかに移動してください。実技に合格しても、剣道形審査を欠席すると審査全体が不合格となり、また後述の剣道形再受審の資格もなくなりますのでご注意ください。
- 3) 各自安全面に注意して審査を受けること。貴重品の管理は各自行うこと。審査中の事故に対しては、主催者では応急処置を講じ、病院等で治療を受けられるよう手配する。また、主催者は、審査中の受審者の事故に対して傷害保険に加入していますが、受審者各自が旅行期間中の疾病傷害保険等に必ず加入してくるようにしてください。(主催者の傷害保険は審査中の傷害の治療費が対象で、それ以外は対象とはならず、審査中以外の事故等に対して主催者は一切責任を持ちません。)
- 4) 全剣連では宿泊・交通手段・食事等の斡旋や手配はしませんので、各自で手配されるようお願いします。
- 5) 会場には駐車場が殆どありませんので、車での来場は遠慮ください。
- 6) 合格した場合は、必ず所属剣道連盟へ(およびヨーロッパの場合はヨーロッパ剣道連盟も)合格を報告すること。
- 7) 日本剣道形にのみ不合格となった受審者は、審査日より1年以内の形再受審が認められます。形再審査対象者となった場合は、全剣連国際部門へご連絡ください。(実技合格後、単に形審査を受けなかったという場合は、この再受審対象にはなれませんのでご注意ください。)
- 8) やむを得ず欠席することが判明した場合は、全剣連へご連絡ください。
- 9) 全剣連で以前に段位受審や段取得の実績がある方は「全剣連番号」が登録されています。今後同じ種目(剣道)で受審を申し込む場合は、申込書の所定欄にその番号をご記入ください。(その全剣連番号をお持ちの方は、今後の全剣連剣道受審申込提出時に、免状のコピーを添付いただく必要はありません。ただし申込書の所定欄に必ずその番号をご記入ください。おわかりにならない方は、お問い合わせください。)

※本審査会の入場は、受審者を優先とし、見学者(付添・家族含む)につきましては、会場の収容人数により入場者数を制限した事前登録制といたします。ただし、申込多数の場合は先着順といたしますので、ご了承ください。

※見学者の事前登録については、後日、各都道府県剣道連盟へ案内通知を送りますので、そちらよりご登録ください

- 1) Please note that all instructions and notices (oral or written) at the venue are given only in Japanese. No special treatment such as interpretation or translation will be provided to foreign language speakers. All applicants are requested to follow the oral/written instructions and notices at the venue.
- 2) Jitsugi exam and the Kata exam could be held in different places. After the Jitsugi examination, the successful applicants' numbers of Jitsugi exam will be announced at each court and the court attendant will give the explanation on the Kata venue. Therefore, the applicants should stay close to the registration desk of the court until the

Jitsugi successful applicants' numbers are announced. (The successful applicants' announcements are made every time after the groups finish Jitsugi.) In case the successful applicants move to the place for the Kata exam, those should follow the instructions of the court attendant and move to the Kata venue immediately.

Even if you pass the Jitsugi exam successfully, if you do not attend the Kata exam, you will lose the eligibility for the 're-taking for Kata exam'.

- 3) Each of the participants should be careful about his/her safety and for others. Please remind that the participants him/herself is in charge of their own valuables. In case of an accident (injury of an applicant) during the examination, the hosting organization shall give first-aid treatment and arrange for medical treatment at a hospital on the day of the event. The hosting organization will contract accident insurance for injury during the examination, but it is strongly recommended that each applicant to take out their own insurance that covers the expenses for diseases/accidents during the whole travel period. (The accident insurance by the hosting organization will cover the expense of the doctor's bill for the injury during the examination only. Other expenses shall not be covered and the hosting organization shall not be responsible for any of those other incidents.)
 - 4) AJKF does not introduce or arrange for your accommodations, transportation or meals. If you are planning to participate in the examination, you must arrange them by yourself.
 - 5) As usually there is very limited space for parking at the venue, you are requested not to go to the venue by car.
 - 6) When you pass the examination successfully, you are strongly recommended to report it to the federation you belong with (*if your Federation is affiliated with EKF, you must report the result to both your Federation and EKF).
 - 7) In case you pass the Jitsugi examination but do not pass the Kata examination, you may apply for a Kata examination only of an AJKF exam within one year from the day of this examination. If you are qualified for this 're-application for Kata' procedure, please contact the AJKF International Office. (If you just do not take the Kata exam after you passed the Jitsugi, you are not qualified for this re-application for Kata exam only treatment.)
 - 8) If you resign for the examination, please report it to AJKF as soon as possible.
 - 9) In case you ever took AJKF exam or acquired a Dan issued by AJKF, you will have an AJKF Registered Number. If so, please write the AJKF number in the application form. (*If you have the AJKF registered Number, you don't need to submit the copy of your current Dan certificate when you apply for a Dan exam in future. Please write the number on the application form. If you lost or want to know your own AJKF number, please contact the AJKF International Office.)
- * **Priority for admission will be given to examinees, while the number of visitors (including chaperones and family members) will be limited by the capacity of the venue. However, if there are too many applications, the admission will be on a first-come, first-served basis.**
 - * **For pre-registration of visitors, an information notice will be sent to each prefectural kendo federation at a later date, so please register there.**

外国剣連所属者のお問い合わせや依頼等については、審査当日に会場係員は対応できませんので、ご質問等は、必ず全剣連国際部門へ事前または事後に各剣道連盟を通じてお問い合わせくださいますようお願い申し上げます。

Please note that the staff at the exam venue cannot deal with the questions and requests

concerning the applicants from the foreign federations because they do not understand English or they are not familiar with the procedure for the foreign Kendo federations' members, which is completely different from the domestic one. So if you have any questions or request, please be sure to contact the International Office of AJKF in advance or after the examination **through each federation.**
